- **Minimum:** Minimum order is \$25.00 net pricing. We will waive the minimum order with a \$10.00 surcharge.
- **Freight:** F.O.B. Shipping Point.
- **Pricing:** All pricing is in U.S. Dollars and is subject to change without notice. Possession of price list or quotation does not constitute acceptance of order.
- **Terms:** 2% Discount within 10 days, Net 30 Days on approved credit.
- **Partial Delivery:** Unless otherwise agreed, Malone Specialty Inc. will make partial shipments and invoice them individually.
- **Shortage or Damages:** All shortages and damages on a shipment must be reported within 48 hours of receipt of goods.
- **Concealed Damage:** All claims for damage are the responsibility of the buyer and should be made to the carrier in writing.
- **Cancellations:** All orders are considered open until formally cancelled by the customer. *Specials can not be cancelled without written consent of Malone Specialty Inc.* All orders for cut and coupled hoses are *NON-CANCELABLE* and *NON-RETURNABLE*.
- **Returns:** ALL returns must be authorized by Malone Specialty Inc. before shipment. A minimum restocking charge of 15% will be applied to all return goods unless an error in shipping or merchandise is defective. Special made to order items are not returnable unless proven defective and all freight must be pre-paid. Credit on account will be issued for authorized returns.
- **Material:** Unless otherwise specified, all fittings and hose couplings are made from carbon steel and finished with a cadmium or zinc plating. Other materials (stainless steel, brass) available upon request. Talk to your Malone Sales Rep.

Returned Goods

All returns must be authorized by Malone Specialty Inc. before shipment. Freight on all returns must be prepaid. A restocking charge will be made on all returned goods. Non-standard and special order products are non-returnable. Credit on account will be issued for authorized returns.

Limited Warranty

Malone Specialty Inc. warrants each new product which it sells to be free from defects in material and workmanship, under normal use and service, for a period of one (1) year from date of sale. In the event that a new product, returned with transportation charges prepaid, is found to be defective during the one (1) year period of this limited warranty, Malone Specialty Inc. will remedy the defect by either repairing or replacing the product.

The limited warranty given herein is limited to repair or replacement of a defective product, and does not apply to any product which is used in an application for which it was not designed, improperly installed, misused, damaged, or altered in any way after sale. This warranty does not cover labor, parts, or materials of a unit or an assembly in which the product is used.
